3. The applicant must have owned a Siberian Husky for at least two consecutive years.
4. The applicant must be willing to sign and consent to the SHCN Code of Ethics and Guidelines for Ethical Breeding Practices.

For **MARKETER MEMBERSHIP** , these requirements are defined as follows:

1. The applicant must be a resident of Nigeria, its territories or possessions.
2. The applicant must be at least 18 years old.
3. The applicant must be willing to sign and consent to the SHCN Code of Ethics and Guidelines for Ethical Breeding Practices.
4. The applicant must obtain two sponsors (may not be members of the same household, close family, or SHCN existing members) who are members in good standing of the SHCN, and who have known the applicant for at least two years.
